## **Annual Quill 2025**

The 199th Annual Communication of the Grand Lodge of Michigan was held at The Soaring Eagle Casino and Resort in Mt Pleasant Michigan.

It started with the Distinguished Guest dinner on Sunday evening, May 18. All the Grand Lodge officers were in attendance along with 19 Past Grand Masters plus representatives of the appendant and concordant bodies and all the out of state guests.

On Monday morning, the BGPs and DDIs/RGLs held their separate meetings. WB Mark Rogers chaired the BGP meeting and RW Tom Braun led the DDI/RGL School of Instruction.

Breakout sessions were offered by the Michigan Masonic Home, the Michigan Masonic Charitable Foundation and the Grand Lodge.

The speaker at lunch was Mitch Albom who was very warmly received. He spoke of the benefits of charitable giving and answered all questions

A meeting of the delegates was held on Monday afternoon. Presentations were given by Robin Blackmore (MMH), Bruce Caswell (MMH Board of Trustees).

All three budgets were presented by Grand Treasurer Larry Inscho PGM.

The Grand Master asked that anyone that was planning on running for any Grand Lodge Officer position to come onto the stage. There were six candidates for the open chairs in the Grand Lodge line. Each was given 2 minutes to speak. A question and answer period followed. There were no candidates for any other positions.

At 8:35 am Grand Master Abbaticchio declared the Annual Communication of Michigan open, tiled and in order.

Grand Secretary Finkel reported that there was a quorum present.

Grand Secretary Finkel presented the proceedings for 2024 which were adopted.

MWGM Abbaticchio gave his address. It was forwarded to the Committee on Division and Reference The report of this committee was adopted.

The report of the Jurisprudence Committee was given by MW Walt Wheeler PGM and was adopted.

The Grand Master proposed the expulsion of Brother AB. Of Menominee Lodge #269. It was supported and accepted.

MW Larry Inscho presented the budgets and they were approved.

A motion was made by Grand Secretary Finkel to advance all current Grand Officers one station and to re-elect the Grand Treasurer, Grand Secretary, Grand Lecturer and Grand Tiler. This was accepted

The candidate for Grand Chaplain was MW Dean Barr PGM. There was no other nominations. A ballot was held and MWB Barr was elected.

There were six candidates for the 2 open chairs of Grand Lodge and 1 for Grand Chaplain The Candidates were:

On the fourth vote, WB Ryan Binkley gained 56.1% and was elected Junior Grand Deacon The other 5 were now balloted on for the Grand Marshal position. On the fourth ballot, with 51.9%, WB Todd Schmitz was elected Grand Marshal

Grand Master Abbaticchio declared Grand Lodge at ease to allow Jan Cross, president of the Michigan Masonic Charitable Foundation Board, to enter and conduct the Annual Meeting of the MMCF. Nominations for the two open Trustee positions were Tom Black and Jeff Downing and both were approved. MW Don Baugher asked for a vote on "Shall the decision of the MMCF board regarding the Legacy Society be overturned?" It was voted and accepted. The name reverts to Lewis Cass Legacy Society.

# **VOTING ON PROPOSED LEGISLATION**

## Amendment #1-2025

**Constitutional Amendment** 

This would change the required date for proposed amendments to be in the Grand Lodge office from 120 days before Annual Communication to December 31. By a vote of 89% this amendment will be forwarded to every Lodge for their vote.

#### Amendment 2-2025

This would make background checks of new petitioners mandatory. Defeated 65.3% to 34.7%, 3 votes short. (a 2/3 majority is required)

# Amendment 4-2025

This would allow for a DeMolay logo on aprons. Defeated 44% to 56%

Grand Secretary Finkel stated that there was no further business

Grand Master Abbaticchio declared Grand Lodge was adjourned until 1:30 pm
