- Meeting was opened in the EA degree in due form at 7:58 p.m. by WM Peter Anders.
- The death of Brother Kenneth Copp and Kaye Bartlett was reported. Kenneth Copp passed away September 14, 2025, in Newburgh, Indiana. He was born November 7, 1932, in Gary, Indiana. He was raised a Master Mason on 1/14/1958. Kaye Bartlett passed away October 31, 2024 at Ohio Lifecare Hospice in Wooster Ohio. He was raised a Master Mason on 5/19/1955. The altar was draped in black and the lodge had a minute of silence.
- Visitors; Worshipful Brother Cornelius Nix BGP/PM (Treasurer of Joppa-Wenona #315) and Most Worshipful Brother Fred Kaiser PGM (Berkley #536) were announced and greeted by WM Peter Anders and the Wardens of Centre Lodge.
- The minutes from the months previous meeting was approved.
- Warrant Orders #869 to #872 were presented with WB Dave Skiendziel motioning to adopt them and WB Jerry Chambers seconding, followed by a vote in the affirmative.

- New Business

 - John Kall motioned to authorize spending maximum of \$400 in Christmas gifts as sponsorship for an in-need family identified by the Salvation Army. WB Dave Skiendziel seconded the motion, followed by a vote in the affirmative.
 - The next Blood Drive is on December 29th at Venue 63 (1517 Bayliss St) between 11am and 5pm.
- WB Ed Morris passed the almoners box around for donations. Current amount collected is at \$10,185.
- Past Masters were recognized by WM Peter Anders.
- Lodge was closed in due form by WM Peter Anders at 8:28 pm
- Members retired to the dining room for fellowship and refreshments to celebrate the installation of officers held prior to the regular communications.
